4. Chair's Remarks

Colin Deakins opened the meeting in 1901 welcoming members of the public for attending. He introduced The Clerk and asked that members of public contact The Clerk in future if ever needed.

Introduced County Councillors who cover Usk and Llanbadoc. Introduced members of Community Council who were present. He informed members of the public that there are two seats available on the Community Council now.

5. County Councillor Participation

Tony Kear & Meirion Howells were introduced by The Chair who then passed the meeting over to Tony so that he could carry out a presentation which provided information on the revised Local Development Plan which identifies the Candidate Sites in Little Mill.

- Identifies land for development
 - Affordable, social & private (economical) residential
 - o Includes land set aside for commercial and / or industrial development
- Identifies land for protection
- Sets out the guidelines and regulations for Councillors and Planning Officers to consider planning applications

The current LDP ran its course in 2021 and is classed as expired. The RLDP has yet to be ratified by MCC.

Consultation took place in November 2023 to consider which candidate sites to move ahead with in the RLDP. A site has been identified in Little Mill adjacent to Cae Melyn for 20 houses. (2018-2033 6,210 homes this does not include windfall sies) action: ask tony for a copy of the slideshow presentation

50% affordable MCC by-law. Public consultation to RLDP opens November until December 2024. If the LDP is approved, it does not automatically mean that the identified sites have planning permission. Any potential developer will still need to seek permission to build on the identified sites.

An online survey is still available.

6. Comments from Members of the public

Members of the public were invited to ask questions or put forward comments to either LCC or County Councillors. Members of public raised concerns surrounding:

- Lack of infrastructure in Little Mill
- Increasing road traffic and speeding through the village
- How long would the site be identified as a candidate site? This would be until 2033 or carry on into the next plan if considered acceptable at the time
- Flooding issues
- Cae Melyn Road has never been adopted by Monmouthshire County Council
