5. Chair's Remarks

The Chair thanked Cllr Deakins for his time as Chairperson.

6. County Councillor Reports

Cllr Tony Kear reported:

1. Storm Claudia led to flooding in Little Mill, properties that had been flooded 12 months ago have been impacted by floods this time around. These should be identified as 'hot spots' and so the drainage around these properties should be prioritised by MCC. There has been a commitment to review the culvert in Little Mill but this is likely to happen after the towns that were affected have been prioritised.
2. Speed Indication Sign at Monkswood has been relocated. Cllr Kear has asked for a review of the SID as it is still not working correctly.
3. Speed data ribbons are due to be installed on the main road at Llanbadoc in early December.
4. Usk Bridge has been struck again by a vehicle.
5. A minor was struck by a vehicle in Little Mill. A member of public has contacted the local MP who has responded that a request for a Zebra Crossing has been applied for the part of the road in question. The location of bus pick-up points is to be reviewed. He is attending a public meeting to discuss speeding concerns and to see if there is interest for a community speed watch.

Cllr Meirion Howells reported:

1. Speed change from Coleg Gwent to the Agricultural college was rejected on the grounds that there would be too many speed limit changes in a short distance.

7. Comments from Members of Public

Glascoed Hwb & Pit Pony Project

Carl Thomas from the Glascoed Hwb attended the meeting to give an overview of a Pit Pony Project that he is launching. Carl Thomas manages a charity that focuses on ex-veterans to help them deal with PTSD and mental health issues. Carl has networked with a Welsh charity that works with Welsh Veterans and Section-A Welsh Pit Ponies to create fire breaks throughout the Welsh valleys. Carl has attended pony training and purchased two pit ponies to use alongside veterans involved with his current charity. A pilot scheme will be running from January and Carl proposes that The Council applies for a tree grant and then he can give time, volunteers and ponies (with a daily cost of £220 for oversight) to help bolster Council owned woodlands and provide the charity with projects.

21. Councillor Reports

Cllr Deakins: meets with Chairperson of Little Mill who has expressed dissatisfaction at the speed in which bookings are settled. The Clerk noted that there had been a discrepancy, but this has been rectified. The Chair reminded The Council that there had been a previous agreement to donate £100 per annum in lieu of room rental for meetings. £50 for remaining year then £100 from April to March 2026-2027.

Cllr. Bowyer: A property in Llanbadoc was broken into – since this took place residents of Llanbadoc have started a WhatsApp group to share information and remain in contact with one another.

Cllr Dando: The railway bridge in Little Mill was struck, and a road was closed for repairs to be carried out. There is now width and height signage on the bridge to signify the size restrictions. A resident has commented that the restrictive notice would be better placed on Berthon Road so that drivers have notice to turn around beforehand. As the road is not adopted MCC would be unable to do any work however LCC has noted the concerns and if there is an issue in the future LCC will revisit the subject.

Cllr Carpenter: Took photographs of Glascoed Lane potholes to submit to MCC, intercepted someone repairing some potholes. A road delay notice was placed on Glascoed lane with no notice within the road closure notice from Highways. Received a complaint about an overhanging hedge, this has been submitted through MyMon.

A staff appraisal template is available from OVW at a cost of £25 – this is to be purchased by LCC. The staff review will be conducted by Cllr Dando and Cllr Bowyer.
